During the quarter ended March 31, 2019, the Company incurred a net loss of \$4,505,171 compared to \$76,544 for the quarter ended March 31, 2018. Significant items making up the change in net loss for the three months ended March 31, 2019, as compared to the three months ended March 31, 2018 were as follows:

- Corporate administration decreased to \$62,573 (2018: \$76,546) as the Company has decreased the cost of office overhead.

- The realized loss on sale of marketable securities was \$4,406,572 (2018: Nil) as the Company sold marketable securities and realized a loss of \$4,518, and also the company issued a dividend resulting in a realized loss of \$4,402,054.

### **Operating Activities**

The Company's cash used in operating activities was \$54,813 (2018: \$163,978). The decrease in the three months March 31, 2019 was due to the decrease in operating loss \$65,573 (2018: \$76,127) and there being no bank indebtedness payments in 2019: \$Nil (2018: \$79,556).

### **Investing Activities**

The Company's cash generated in investing activities was \$141,755 (2018: \$2). The increase in the three months March 31, 2019 was due to proceeds received from the sale of marketable securities \$141,741 (2018: \$Nil).

### **Financing Activities**

The Company's cash outflow in financing activities was \$398,098 (2018: \$Nil). The outflow in the three months March 31, 2019 was due to the Company issuing a cash dividend \$398,098 (2018: \$Nil).

### **Cash Resources and Going Concerns**

At March 31, 2019, the Company had \$81,325 in cash and working capital of \$139,551. To continue to operate in the future, the Company will have to raise additional equity or form strategic partnerships; however, there cannot be any certainty that additional financing can be raised or strategic partnerships can be found.

## **OPERATIONS**

In 2018, the company disposed its subsidiary, Jayden Resources (Canada) Inc. ("Jayden Canada"). The Company is principally engaged in the business of acquiring, exploring and developing interests in mining projects. To date, the Company has not generated revenues from its principal activities and is considered to be in the exploration stage.
